Whisky Business: regulating and recording the whisky industry

2023 marked the 200th anniversary of the 1823 Excise Act which had a profound impact on the development of the whisky industry in Scotland. Today Scotch Whisky has become the UK's biggest food and drink export with more Scotch Whisky sold worldwide than Irish, US and Japanese whiskies combined worth more than £5.5bn to the economy¹.

History and heritage are crucial to the industry which has a growing number of corporate archivists, a development that dates back to 1990 when United Distillers Ltd first established their archive now managed as the Diageo Archive. Furthermore, there are rich resources for researching the whisky industry with nearly 100 archive collections relating to whisky distilleries held in repositories and by private collectors across Scotland. In addition to these business archives, records relating to the whisky industry can also be found in public records such as parliamentary papers and customs & excise records alongside the records of various trade associations.

This special issue of the journal is interested in articles that share recent research into any aspect of the whisky industry that has made use of archive collections. We also encourage articles from archivists who may wish to reflect on the ways in which the collections they manage have been used by business for their own purposes such as celebrating anniversaries or product development.

Potential topics include but are not limited to the following:

- The development of the whisky industry since 1823
- Histories (comparative or otherwise) of distilleries
- The global impact of Scotland's whisky industry
- Challenges of collection development and/or archival research in the 21st century
- Resurrecting distilleries and brands through archival research
- Case studies exploring business archive collections in focus

Submissions

We welcome a range of papers in different formats and word lengths from articles, reviews, case studies, collections in focus pieces and reflections. Articles will typically be between 5,000-8,000 words but other pieces will be shorter.
